

DIOKSIŅŲ, FURANŲ IR DIOKSIŅŲ TIPO PCB MATAVIMŲ REZULTATAI

Atliktų matavimų tikslas – nustatyti į aplinką išmetamų dioksinų, furanų ir dioksinų tipo PCB (polichlorinti bifenilai) koncentraciją ir patvirtinti atitiktį leistinoms išmetimų normoms.

Matavimų periodas

Nepertraukiamas dūmų mėginio ėmimas buvo vykdomas nuo 2025 m. rugsėjo mėn. 16 d. 00:00 val. iki 2025 m. rugsėjo mėn. 25 d. 09:40 val. Nepertraukiamas mėginių ėmimo ciklas vyko trumpiau, nei įprastai, kadangi jėgainėje vyko metinis planinis remonto darbų stojimas.
